- KCGRC will accept entries of Golden Retrievers first, according to Option 2 in the AKC Obedience Rules & Regulations Manual, then from all breeds until the entry limit of obedience entries per day is reached. The capacity of the facility limits obedience not to exceed 8 hours of judging time per day per judge.
- Open to all AKC Recognized Breeds and All-American Dogs listed in the AKC Canine Partners Program, with Golden Retrievers, receiving first priority (According to Option 2 in the AKC Obedience Regulations).
- A qualifying score is required for all prizes in the regular classes but is not required for prizes in the non-regular classes. "Dog" when applied here means either sex.
- All dogs will be judged in jump height order in all obedience in which jumps are used.
- Judging will be in ascending order beginning at 4 inches. \* Transfers are allowed per AKC regulations.

#### SAFETY, BEHAVIOR and LIABILITY

- The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all exercises safely.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such a case, no refund of any fees paid will be made.
- The Kansas City Golden Retriever Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- The Kansas City Golden Retriever Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Kansas City Golden Retriever Club or any official thereof.
- All dogs must **be on leash at all times** when on trial grounds except when showing in the ring.
- The Kansas City Golden Retriever Club may cancel or delay this event in extreme weather conditions.

## **REFUNDS**

- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- Bitches in season are not permitted to compete in Obedience Trials. Refund of entry fees for bitches come in season after the closing date for these shows will be made only upon written certification by a licensed veterinarian. The refund amount will be the entry fee paid less \$10.00 per day. All claims for such refunds shall be made with the show secretary not later than ½ hour prior to the start of any obedience during the day of the show.

#### **RINGSIDE**

#### **ENTRIES**

- Entries not on official AKC forms or photocopies of entry forms without the Agreement and Rules on the reverse side are not acceptable.
- Changes, additions, or corrections to entry forms must be received in writing prior to the closing of entries. Owners are
  responsible for errors in making out entry forms and no entry fee will be refunded for such errors or cancellation of entries after
  the published closing date.
- Please remember to mail your entries early to avoid possible postal delays!
- NOTE: Please waive signature requirement when sending entries by Express Mail, FedEx, etc. Entries will not be accepted when a signature is required.

# SITE INFORMATION

- BUILDING HOURS: The building will open at 7:30 am Saturday or Sunday and will be closed thirty minutes after the end of the last class each day. NO DOGS MAY BE LEFT OVERNIGHT IN THE BUILDING Building will be locked and no security will be provided. Crates/Equipment may be left overnight; however, the Kansas City Golden Retriever Club nor Kansas City Dog Training Club will not be responsible for any lost or damaged items left at the show site.
- **COVID GUIDELINES:** KCGRC will be following all Local, State and Federal guidelines which will be updated and detailed fully in the Judging Program after entries close.
- **FOOD:** There will be no food concession at this show site. There are various fast-food restaurants near the show site. Outside food may be brought into the facility. Volunteers get free lunch.
- ADA PARKING: Will be marked in the front of the building.
- OBEDIENCE CRATING AND MOVE IN: Crating is limited and building occupancy codes must be adhered to. No Xpens. Please stack crates as much as possible and use a mat under ALL crates. No dollies/wagons in the crating area. All crates must be in the designated crating area. Set up is no earlier than 2:00 p.m. Friday or Saturday 7:30 a.m.
- VEHICLE PARKING: There is parking at the GKCDTC building on the southwest side of 63rd Terrace except for Brookside Electric's marked parking. DO NOT block the gate on the north side of 63rd Terrace. There is parking at the UMB Bank parking lot on the north side of 63rd Street across from GKCDTC. Please do not load and unload from the Bank parking lot. Park at the bank only. There will be marked spots in front of GKCDTC for loading and unloading. No Parking in the lot West of the building next door to GKCDTC. There will be parking on SUNDAY only at Crump's Paint and Decor. Please clean up after your dogs in these lots.
- CLEAN UP: Exhibitors are to clean up, inside/outside of the building, pertaining to their dog(s). Please do not use the bank across the street's grass as a potty area.
- All dogs must remain on leash or kenneled unless showing in the ring.

#### INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, particular variety, please (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience should mark Breed as "All-American Dog/Mixed Breed". Sire and Dam information shall remain blank for mixed breed entries.
